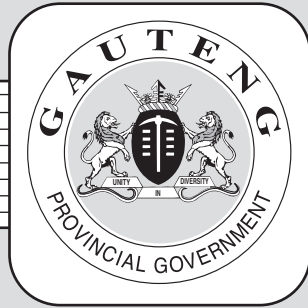

It is hereby notified in terms of the provisions of Section 60 of the Town-planning and Townships Ordinance, 1986 (Ordinance No 15 of 1986), that Local Authority Notice No 70 of 2021 in the Gauteng Provincial Gazette No 247, dated 28 July 2021, with regard to Amandasig Extension 78, is hereby rectified as follows:

Substitute the paragraph under 1.3 Endowment:

“The township owner shall pay endowment for an area of **408m²** in terms of Regulation 44(1) of the Town-planning and Townships Regulations, to the City of Tshwane. The amount of this area shall be used by the City of Tshwane for the acquisition of land for park and/or public open space purposes.

with the following paragraph:

“The township owner shall pay endowment of **R140 000,00** for an area of **408m²** in terms of Regulation 44(1) of the Town-planning and Townships Regulations, to the City of Tshwane. The amount of this area shall be used by the City of Tshwane for the acquisition of land for park and/or public open space purposes.”

Substitute paragraph 6.2.17 in the Annexure:

“All development shall be in accordance with approved Site Development Plan SDP 4/2443/06”
